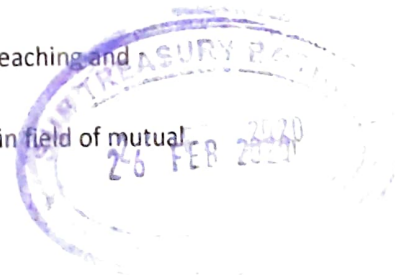

- d. Conduct seminars, international conferences that expertise knowledge and renew motivation and confidence in field of mutual interest.
2. Establish a mutually beneficial partnership between colleges that allows a flexible and creative response to the organizational mission and other needs of both **PARTIES**.
3. Shared use of facilities including classrooms, office and library facilities that promotes collaboration of students, faculty and other staff in field of mutual interest (subject to internal approvals, permissions and consents).

TERMS

This agreement will become effective upon the date of signature by both **PARTIES**. It shall remain valid for a period of five (5) years from the date of the last signature, with the understanding that it may be modified by written mutual consent of both **PARTIES**. This Agreement may be terminated by either **PARTY** with advance written notice of at least thirty (30) days. Upon notice of termination both **FIRST PARTY** and **SECOND PARTY** agree to work in good faith to enable visiting scholars to complete their respective research programs unhindered by the termination. The agreement may be extended by mutual consent of the two **PARTIES** after the five-year period, and it must be renewed in writing. This Memorandum of Understanding in English is hereby signed in two (2) copies with one (1) copy remaining in the possession of each **PARTY**.
